## CONSTITUTION & RULES

1)	Name of society:	The Cornwall Astronomy Society
2)	Membership:	Open to all, subject to these rules.
3)	Aims & Objectives:	To foster the practice and enjoyment of astronomy, cosmology and related interests.
4)	Meetings:	To pursue these aims and objectives by:
		<ul><li>(a) holding regular meetings, (normally two per month).</li><li>(b) to conduct such other activities as the membership may decide.</li></ul>
5)	Committee:	The day to day running of the Society shall be conducted by a committee, elected by the membership and responsible to them.
		(a) Election: A committee shall be elected at the annual general meeting, normally the first meeting in December each year.
		<ul> <li>(b) Composition: The committee shall normally comprise:- Chairman: Secretary: Treasurer: Newsletter Editor: and such other officials, as may be required.</li> <li>(c) Duties: The proper running of the Society in</li> </ul>
		accordance with the true spirit and meaning of these rules subject always to the wishes of the membership. Each official shall normally report monthly to a meeting of the Society.
6)	Subscriptions:	Shall be determined annually at the AGM (Dec) and normally payable to the Treasurer on or before this date for the forthcoming year. New members shall pay the appropriate subscription on joining the Society and subsequently as above.
7)	Accounts:	The Treasurer shall maintain proper accounts at a Bank or Building Society. The Treasurer shall pay all moneys into this account and maintain correct records. The authority of both Chairman and Treasurer shall be required to withdraw moneys or issue cheques.
8)	Interpretation of Rules & Voting:	All voting in Committee or Society Meetings including any of matter not covered herein shall normally be by simple majority vote of paid up members.
9)	Amendments to constitution and Rules:	May be made at the AGM or a specially convened meeting.
10)	Dissolution:	Dissolution of the Society shall be only by majority vote. All assets and moneys shall be given only to a similar astronomical society or to The British Astronomical Association.
11)	Revoking membership:	A member can be removed and barred following behaviour that is unbecoming or damaging to the
